## THE SWEDENBORG SOCIETY

Report of the Council for the twelve months ended 31st December 2014.

### TRANSLATING, EDITING, PRINTING AND PUBLISHING

No new titles were published during 2014 but a great deal of work was done on preparing books for publication for 2015 and beyond. Works completed and made ready for the press included:

Homero Aridjis's *An Angel Speaks: Selected Poems*, the third volume of the Swedenborg Archive series. The book stems from a reading given at Swedenborg Hall in 2012, and features an introduction from the Nobel Prize winning writer J M G Le Clézio. The book follows on from the huge success of the first two volumes in the series, Iain Sinclair's *Blake's London* (now in a second printing) and *Swimming to Heaven*.

William Rowlandson's essay *Imaginal Landscapes: reflections on the mystical visions of Jorge Luis Borges and Emanuel Swedenborg*, featuring a foreword by Gary Lachman. As with Homero Aridjis's book above, this essay stems from a lecture given at Swedenborg Hall.

Norman Ryder's *A Descriptive Bibliography of the Works of Emanuel Swedenborg (1688-1772)* vol. III, which includes a description of editions and translations of the works of Swedenborg that were first published or composed between the years 1756-62. Work on volume four of the Bibliography is progressing.

Other books in preparation during 2014 include: David Dunér's *Cosmology, Matter, Mathematics: Essays on Swedenborg's Natural Philosophy*; Malcolm Peet's *Medicine, Mysticism and Mythology: Garth Wilkinson, Swedenborg and Nineteenth-Century Esoteric Culture*; and John Haller's *Distant Voices: Sketches of a Swedenborgian World View*.

Work has started on volume four of the Swedenborg Archive series. This is to include a collection of original letters and other documents by the influential Japanese Zen Buddhist scholar D T Suzuki (1870-1966) held in the Society's archive. These rare items were compiled during the first decades of the twentieth century, when Suzuki was commissioned by the Society to translate Swedenborg into Japanese.

Important work continued on new translations of Swedenborg's works. Ken Ryder made great progress with his translation of Swedenborg's *Divine Love and Wisdom*. The work is nearing completion.

Translating and editorial work by John Elliott on dual language English and Latin editions of first, *Doctrina Novae Hierosolymae de Domino / The Teaching of the New Jerusalem concerning the Lord* and second, *Doctrina Novae Hierosolymae de Scriptura Sacra / The Teaching of the New Jerusalem concerning Sacred Scripture* were both completed. The volumes await typesetting.

Similar dual language editions of *Doctrina Vitae pro Nova Hierosolymae ex praeceptis Decalogi / The Teaching for the New Jerusalem concerning Life*; and *Doctrina Novae Hierosolymae de Fide / The Teaching of the New Jerusalem concerning Faith* were in preparation in 2014, with Robert Gill as consultant.

Under the guidance of Dr Jonathan S Rose, work in compiling and arranging additions and corrections to *A Lexicon to the Latin Text of the Theological Writings of Emanuel Swedenborg (1688-1772)*, ed. Dr John Chadwick and Dr Jonathan S Rose was undertaken by Erik Halterman.

The Society's digital publishing programme also underwent substantial development. The following titles were made available as ebooks (EPUB and Kindle):

- *Swedenborg; Introducing the Mystic* by R W Emerson;
- *The Grand Theme and Other Essays* by Anders Hallengren;
- *Memoirs of Swedenborg* by Carl Robsahm;
- *The Five Ages* passages from Swedenborg with a commentary by P L Johnson;
- *Philosophy, Literature, Mysticism* edited by Stephen McNeilly;
- *In Search of the Absolute* edited by Stephen McNeilly;
- *Between Method and Madness* edited by Stephen McNeilly;
- *On the True Philosophy and the True Philosopher* edited by Stephen McNeilly;
- *The Arms of Morpheus* edited by Stephen McNeilly.

## **ADVISORY AND REVISION BOARD**

The Board met on 6 March and 11 September to review the Society's continuing literary projects listed above and consider proposals for new ones. In addition to the completion of volume three of Norman Ryder's *A Descriptive Bibliography of the Works of Emanuel Swedenborg (1688-1772)* substantial work was also undertaken on volume four. New projects discussed included a Latin edition of Swedenborg's indices for *Apocalypsis Revelata* and the English translation of the passages of *Arcana Caelestia* references in *New Jerusalem and Its Heavenly Doctrine*. Both projects are under the stewardship of John Elliott. The Board was pleased to welcome two new members. Revd Alan Cowley and Alex Murray (the Swedenborg Society's assistant librarian) joined the Board having previously attended meetings as guests. Their membership was approved by the Council and ratified at the Society's 2014 AGM.

## **LIBRARY AND ARCHIVES**

As with previous recent years, the major work on the library and archives in 2014 involved the entering of data onto the Society's online catalogue, and it continued to employ assistant librarian, Alex Murray, for three days a week for these purposes.

The catalogue currently lists 7,400 items and 2014 has seen the completion of the cataloguing of one of the 'high interest' sections of the archive, the correspondence section (section K). There are 163 shelf marks for this section of the archive, with each shelf mark containing numerous (in some cases literally hundreds) of individual letters. Records of senders and recipients, and

of dates of letters have all now been made and added to the catalogue.

Progress was also made in the cataloguing of pamphlets (section S4), with 320 out of the 470 shelf marks now being completed. Similar to the correspondence section, each shelf mark of S4 consists of dozens of individual tracts and a total of 2,100 have been listed to date. The library assisted numerous researchers during the course of the year, including visitors to Swedenborg House and remote enquiries made by email, telephone and post. Notably, the library assisted the 'Art Across The City' project held in Swansea, supplying artist Jeremy Millar with an image from its archive for use in his contribution, *Am I Glad To Be Here!*, a 2-sided digitally printed flag that was installed at the Guildhall Rotunda, Swansea.

In last year's report we mentioned the possibility of the library becoming a members' library. A decision on this has been put in abeyance as we seek guidance in our application for national archive and museum status.

## **ENHANCEMENT PLAN**

In response to legacies received during 2013, the Council agreed to provide greater financial support for the Society's core aims and activities. During the early months of 2014 the Society's newly appointed Executive Director drafted a document outlining improvements over a five-year period. It was agreed that greater resources were to be given to the Society's publishing, exhibition, residency, film and conference activities. It was also agreed that support was to be given to entirely new initiatives such as applications for national museum and national archive status, and to establishing postgraduate research scholarships and closer institutional links with universities and other academic organizations. The enhancement programme is also to involve substantial building upgrades.

By the end of 2014 the first phase of the enhancement plan had begun. This involved upgrades to the Society's public meeting rooms (see Premises), the appointment of new book distributors (see Distribution) and new ebook publications (see Publishing). In anticipation of an application for national museum and national archive status it was also agreed to review the Society's staffing infrastructure.

## **DISTRIBUTION**

As just noted, agreements were opened with two new distribution companies. The first, involving Combined Book Services (of Tonbridge, Kent) is an agreement for nineteen titles to be distributed within the UK. At the end of year CBS had placed Swedenborg Society publications into most major UK Booksellers including Foyles, Blackwells, Daunt Books and Waterstones, and special Swedenborg 'Sections' can now be found at Foyles (London) and Blackwells (Cambridge). The second, involving the Swedenborg Foundation of West Chester, USA, is an agreement for seventeen titles to be distributed across North America.

Sales. The gross retail value of books sold was £18,204, compared with £20,126 in 2013. Counter sales in the shop were £4,343.28 (£6,894 in 2013).

Grants. Grants of books totalling £351.88 were made to individuals around the world.

## **SWEDENBORG PUBLISHERS INTERNATIONAL (SPI)**

The Society is a member of this umbrella body which provides funding for translation and publishing projects around the world. In May, under the auspices of SPI, the Society made a contribution of £1,500 to Lenka Máchová for computer hardware and software upgrades. This was to enable Lenka to continue her translation and publishing programme of Swedenborg's works in the Czech Republic.

## **PUBLICITY**

The Society's ongoing Publicity strategy embraces a variety of media types and outlets. The online newsletter continues to grow and reaches a list of nearly 1,500 interested individuals. Continued use was made of the Society's website, Facebook and Twitter accounts. The Society's Facebook page has around 1,000 followers but via its associated links, postings can reach as many as 7,000 friends.

The Swedenborg House blog continues to present a series of articles attracting over 8,000 annual visits from 97 different countries worldwide. As usual, the Society was open to visitors as part of Open House London on the afternoon of 20 September and welcomed around 200 visitors. Open House weekend offers a great opportunity for friends of the Society to come and view our beautiful Grade II listed headquarters in Bloomsbury.

On 26-27 June the Society ran a bookstall at the Early Modern Prophecies Conference held by Goldsmiths University and on 29 July the Society gave a talk on its activities to the General Church of the New Jerusalem's British Academy Summer School, at Purley Chase. On 18 September the Society hosted the launch of the Apocalypse of John card set by the General Conference of the New Church's Apocalypse Study Group.

P L Johnson edited a further two issues of the Society's newsletter *Things Heard and Seen* which is posted to all members and some others and is available free of charge in the bookshop. Continued use was made of print and online listings including *Time Out* and *allinlondon*. A Swedenborg House Goodreads account was set up and via the collaborative events described in the following section (Curated Events), the Society made good use of external websites to publicize Swedenborg House events.

Continued use was also made of more conventional publicity methods including printed invitations and printed flyers, posted to the press and selected individuals.

## LECTURES AND MEETINGS

The Society had another successful year of public meetings, with high attendance and many new visitors. On the 25 January, Professor David Berman, Fellow Emeritus in the Department of Philosophy at Trinity College Dublin, gave a lecture entitled 'The Logic and Credibility of After-Death Existences' at the Society's Birthday Meeting. An audio recording of the lecture was published online via the Society's YouTube channel.

On 3 April, the Society's long-standing Vice-President and Director of the Scientific and Medical Network, David Lorimer, gave a talk entitled 'Towards a Culture of Love and Wisdom'. On 26 June the Society held its Annual General Meeting and Stephen McNeilly gave a brief presentation of the Society's newly drafted enhancement plan. Following this John Cunningham, the Society's President, gave an absorbing and heartfelt talk entitled 'Charity and Use' which is to be published in the Society's newsletter *Things Heard and Seen*.

On 27 November, Ken Worpole, Emeritus Professor in the Cities Institute, London Metropolitan University, gave a presentation entitled 'The Light of the World, the City, the Society on a Hill: Utopianism and Town Planning'. This is to be published by the Society in 2015.

## CURATED EVENTS

As with previous years the Society also enjoyed a rich and diverse programme of collaborative events during 2014. On 20 March, in association with Etruscan books, the Society held an evening of readings with the celebrated writers John Healy, Tom Leonard and Nicholas Johnson.

During October and November, and in conjunction with the international arts organization Artangel, the Society organized three events. The first was a Q&A with the Brazilian artist José Damasceno on his installation/exhibition at the Holborn Library entitled *Plot* (6 Oct). The second involved an informal talk by the acclaimed and award winning architect David Kohn on the spatial play of Damasceno's sculptural intervention (27 Oct) and the third was a presentation by John Ó Maoilearca, Professor of Film and Television Studies at Kingston University, entitled 'Paraconsistent Perception' (10 Nov).

On 27 September, in collaboration with Scalarama, the Society presented a double bill of films by the renowned filmmaker Jim Jarmusch, known for his life-long interest in William Blake and more recent explorations of Swedenborg (29 Sept). The films shown were *Dead Man* and *Mystery Train*.

On the 16 October, in collaboration with Waterside Contemporary, the Society also hosted a performance by the artist Oreet Ashery entitled *21st Century Carpet Sale! A Legendary Collection*. The performance included cut sections of the old Swedenborg Hall carpet and welcomed many contemporary curators and artists.

All of the above events were well attended, bringing new visitors and marketing opportunities to Swedenborg House.

## MEMBERSHIP

Fifteen new members were enrolled during the year. The deaths of eight members were reported to the Society. The total membership for 2014 was 730 members.

## FINANCE

Total incoming resources for the year amounted to £377,769 (£738,112 in 2013). Voluntary income was £92,440, of which £80,073 came from legacies. Investment income was £218,778 (£208,970 in 2013). Income from the hire of rooms was £48,347 (£45,566 in 2013) and book sales were £18,204 (£20,126 in 2013). Total resources expended were £330,954 (£290,396 in 2013), giving a surplus for the year of £46,815. The total value of the investment portfolio at 31st December 2014 was £4,775,743 (£4,628,191 at the end of 2013).

The Society's investment objective is to produce a balance between immediate income to support current projects and longer-term capital appreciation. This is achieved through a diversified portfolio with a medium-risk profile, comprising a mixture of equities and fixed interest stocks with a ratio of 75% equities and 25% fixed interest. It is considered that this objective was achieved during the year.

## RESERVES POLICY

Of the Society's declared objectives, the work of translation, revision and publication are regarded with the highest priority. Here however finance is not the only restriction. Human resources, in the form of capable, specialized translators, are vital to the Society's progress. Much of this work is long-term in character, and therefore designated reserves are justified to ensure the continuity of operations.

Part of the Society's income arises from property. The Society owns its freehold premises, in the heart of our capital city, which provides facilities for its activities (as well as rooms for hire available to others), together with office space which is commercially let. Both the income and associated expenses vary widely, and here again justify a specific reserve to cover fluctuations.

Another part of the Society's income, albeit unpredictable, comes from gifts and legacies. In the absence of specific restrictions, it had been past practice to add these to our general fund to provide sufficient investment income. The Council would seek to continue this practice, but recognizes its duty to apply the resulting increased income to further the Society's charitable objects. The Council's policy, therefore, is to keep the operating surplus/deficit within +/-5% of annual income averaged over three years. For the purpose of calculation, any gifts or legacies are excluded. These would be added to the Society's reserves to generate additional income for the future. This policy is subject to development, and is reviewed at intervals of not more than three years.

## **PREMISES**

Substantial upgrades and refurbishments of the building were undertaken during August. The Gardiner Room, the Wynter Room, the Hall, the Shop and the Staircase were all redecorated and installed with new exhibition track lighting. Swedenborg Hall was also fitted with electrical blinds (over the skylight) and new audio/visual equipment. The old Axminster carpet was removed and the oak flooring restored to its original condition. The dark protective grids over the stained glass windows were removed and replaced with new sheets of strong, transparent plastic.

Museum standard UV protective blinds and window covers were installed in the Wynter Room to protect the valuable collection of books already installed and in preparation for future exhibitions of light sensitive material. The above upgrades represent stage one of the Society's aim to 1) restore, where possible, the original architectural features of the building and 2) have the public areas prepared to accredited museum standards. For this second aim a Building Preservation Handbook was also in preparation. Elsewhere in the building the radiators to the second floor offices had been repaired and, in line with the Society's new Health and Safety document, Adams Environmental Ltd had been contracted to inspect the entire building for asbestos.

## **COUNCIL AND OFFICERS**

Mr John Cunningham, a long-standing member of the Council and Chairman of the Council from 1993 to 2006, was re-elected President of the Society for the year 2014/15 at the Annual General Meeting held on 26 June. At the same meeting Dr Anders Hallengren and Mr David Lorimer were re-elected as Vice-Presidents of the Society for the year 2014/15, and Mr Alec Morley was elected as Hon. Treasurer for the same period. Mr Howard Turner, Mr Michael Hiller and the Revd F C Elphick were retired by rotation under Article 32 and offered themselves for re-election. They were duly elected as ordinary members of the Council. Three nominations for election as ordinary members of the Council had been received at the Annual General Meeting held on 26 June. These were Revd Alan Cowley, Ms Jane Lee and Mr Nigel Sutton. All were voted onto the Council. After several years of service Professor Malcolm Leder retired from the Council on 25 June. Between August and early December Mr Richard Lines was co-opted onto the Council as Hon. Secretary.

All paid-up members of the Society are eligible for election to the Council, which is the Society's decision-making body, in accordance with the procedures set out in the Articles of Association. The Council has the power to fill casual vacancies by co-option. New members of the Council are given copies of the Memorandum and Articles of Association and are advised

by the Chairperson and Executive Director of their duties as company directors and charity trustees. Council decisions are taken by majority vote.

## **ORGANIZATION**

2014 saw several changes to the Society's staffing infrastructure. During April Stephen McNeilly was appointed Executive Director to give direction to the Society's ongoing programmes and enhancement initiative. In November Rebecca Wells was appointed Administrator. In August Richard Lines, the Society's Company Secretary for 12 years, took voluntary redundancy. Eoin McMahon, the Society's Property Manager, continued in his post throughout the year, as did Alex Murray, Assistant Librarian, whose contract was extended for a further year until 30th April 2015. James Wilson, Assistant Editor and Librarian, continued in this role and took on increased responsibilities in publishing. Victoria Rood was contracted on a short-term basis as a Marketing and Publicity Representative, and Jan Evans and Lue Cuttiford gave valuable administrative support in the office during a period of transition. Victor Coles FCA kept the Society's books and prepared the Annual Accounts. Gusztav Varga was appointed Concierge/Doorman on a one-year contract and Patricia McMahon has continued to assist Eoin with the cleaning of the building. Both Eoin and Patricia McMahon gave notice that they were intending to retire during April 2015. At the time of their retirement they will have worked for the Society for 26 years.

As well as paid staff and contractors, the Society has also had the help of a number of volunteers. John Cunningham continued to attend regularly at Swedenborg House, giving valuable service in the bookshop to relieve staff members, as well as continuing to help Eoin McMahon with numerous maintenance jobs around the building. His help has been greatly appreciated. As with previous years David Lister continued to attend on a weekly basis, giving valuable support to the staff and the Executive Director. Michael Hiller gave useful help in the shop on Wednesday lunchtimes. The work of volunteers is greatly appreciated and valued by the Society.

## **COMPANY MATTERS**

This report represents a Directors' Report as required by section 417 of the Companies Act 2006. In its preparation the Council has taken advantage of the exemption available to small companies under Part 15 of the Companies Act 2006.

## **RISK ASSESSMENT**

The general provisions of the Health and Safety at Work Act 1974 are such that it is incumbent upon the Council of the Society to exercise a duty of care to ensure; as far as is reasonably practicable; the safety of their employees at work by maintaining safe plant; safe systems of work; safe premises; ensuring safe access to and egress from the premises and maintain a safe working environment without risks and with adequate facilities and arrangements for staff welfare, also ensuring adequate instruction, training and supervision. The Swedenborg Society is also bound by the Act to ensure the safety, while on its premises, of all persons, employees,

contractors, visitors either working or otherwise using the facilities there. During 2014 the Council began a comprehensive review of its overall Health and Safety Policy and its Risk Assessment procedures. A new Health and Safety Policy was drafted and risk assessments were begun. The Council have determined to review these policies annually.

## **PUBLIC BENEFIT**

The Society has complied with the duty imposed by section 17 of the Charities Act 2011 to have regard to public benefit guidance published by the Charity Commission. The Council considers that, having regard to its translating and publishing programme, its bookshop, its programme of lectures and events (which are open to the public) and to the publicity given through the website, leaflets and press releases, the Society is acting for the public benefit in pursuance of its aims and objects as set out at the front of the report.

## **CONCLUSION**

Some aspects of the report are specially worth noting. We are applying for national museum status and national archive status. The first item has led to the refurbishment and great improvement of the interior of our rooms as mentioned under Premises, and the second item has been made possible by the enormous amount of work done by Alex Murray and James Wilson in computerizing the archives outlined under Library and Archives. Another important change is the retirement, after 26 years, of our resident Property Manager Eoin McMahon and his wife Patricia who have looked after our beautiful but aging premises so well. We wish them well for their future. Richard Lines took voluntary redundancy after 12 years as Secretary. Other changes to the staff infrastructure have included the appointment of Rebecca Wells as Administrator and Stephen McNeilly as Executive Director. In the course of 2014 we maintained the chief and original object of the Society which is the preparation of works for publication, both on traditional paper and electronically, for which I would like to thank Stephen McNeilly and James Wilson. Swedenborg had a fascinating and many faceted character, whose writings, though from a man

of his own time and social class still cast an unique light on the mystery of our existence. Our Enhancement Plan seeks to bring this to a wider audience.

**1. ACCOUNTING POLICIES**

**Accounting convention**

The accounts are prepared on a going concern basis, under the historical cost convention as modified by the revaluation of certain fixed assets and to include a nominal value of stocks.

**Compliance with Accounting Standards**

The financial statements have been prepared in accordance with the Statement of Recommended Practice (revised 2005) "Accounting and reporting by charities" ("SORP 2005") and applicable accounting standards and the Companies Act 2006, except as noted below.

As the company is a small company as defined by the Companies Act 2006 it is exempt from preparing a cash flow statement and has taken advantage of this exemption.

**Fixed assets**

The freehold land and property is stated at valuation. Matthews and Son, Chartered Surveyors prepared the current valuation on 31 December 2001. The directors consider the appropriateness of the valuation at the end of each financial year and consider whether there has been an impairment in the value of the property. No depreciation is charged in relation to the property as the directors consider the annual charge would be immaterial taking into account the residual value of the property. See note 8 for further information. Costs of improvements to the property are charged to expenditure within the statement of financial activities annually.

Fixtures, fittings and office equipment are depreciated on the following basis:

Fixtures and fittings	7% - straight line
Office equipment	50% - straight line.

**Heritage Assets**

The Society holds an extensive library and archive relating to the life and works of Emanuel Swedenborg, held primarily for the purposes of transferring knowledge and promoting culture which are disclosed on the Balance Sheet as heritage assets. This collection is considered to be a heritage asset and is stated in the balance sheet at an attributed value on the insured value and, as allowed by FTS 30, is not depreciated as it is considered to have an indefinite life. Following the implementation of FTS 30 material additions to the library will be capitalized.

**Investments**

Investments are stated at market value. Realized and unrealized gains on revaluation are disclosed in the Statement of Financial Activities. Realized gains are calculated as the difference between sale proceeds and market value, or cost if acquired during the year.

**Stocks**

Stocks of books, printed sheets and papers are included in the accounts at a nominal value of £100, based on significant uncertainties with regards to the realizable value of the books held. Disposal proceeds and acquisition costs are taken to the Statement of Financial Activities in the year in which they are received/paid.

Legacies and gifts are credited to the Statement of Financial Activities when there is reasonable certainty of receipt and the amount can be ascertained.

**Sales of books**

Sales of books are stated net of trade discounts.

**Investment income**

Investment income is accounted for in the Statement of Financial Activities on a receivable basis.

**Cost of generating funds**

Cost of generating funds includes all publicity expenses incurred in raising the profile of the Society.

**Shop and stock rooms, library and hall expenses**

Shop and stock rooms, library and hall expenses comprise direct expenses and a proportion of the total property expenses, based on estimated floor space as follows:

The freehold land and property is stated at a valuation which was prepared in 2001. The trustees consider the appropriateness of the valuation at the end of each financial year and consider the value included in these financial statements to be materially correct. However under accounting standards FRS15, Tangible Fixed Assets, a formal valuation should be undertaken by a property professional on a regular basis to confirm that the valuation is still appropriate. The trustees do not consider that it is a good use of the Society's resources to pay for a valuation and therefore a valuation has not been obtained. This policy does not accord with the requirements of FRS 15.

The library and archives are heritage assets. They are included in the financial statements at a valuation based on insurance value. The valuation was undertaken internally prior to 2005 and is reviewed on a regular basis by the Society. The library was established in 1824 and provides an important resource for those researching Swedenborg. It has four main sections: The Swedenborg collection; the Archives; Collateral titles and Periodicals. The library is a research library and is open to members of the Society and non-members.

- (e) Holding examinations on the works of Swedenborg.
- (f) Opening, supporting and maintaining branches and depots in any part of the world.

THE SOCIETY was established in 1810 (incorporated 1925) for the purpose of translating and publishing the works of Emanuel Swedenborg. Annual Membership subscriptions £20 or upwards (£15 for those aged 65 or over, students and the unwaged). Life Membership, £200 (£150 for those aged 65 or over). For a married couple—one-and-a-half times the individual subscription (applying to both annual and life membership). Application for membership must be in writing and approved by the Council.

SUBSCRIPTIONS, DONATIONS AND LEGACIES are most welcome. Subscriptions and donations may be sent to the Administrator or the Society's Collectors, a list of whom appears in this Report.
