- (c) Organising meetings, lectures and other functions as a means of directing attention to, and promoting interest in, the works of Swedenborg.
- (d) Encouraging the study of the works of Swedenborg by maintaining a Reading Room and Library.
- (e) Holding examinations on the works of Swedenborg.
- (f) Opening, supporting and maintaining branches and depots in any part of the world.

# Report of the Council for the twelve months ended 31st December 2013

#### TRANSLATING, EDITING, PRINTING AND PUBLISHING

Seven titles were published by the Society during the year: *The Grand Theme and other essays* by Anders Hallengren; *Lost Rivers of London* by Iain Sinclair; *Philosophy, Literature, Mysticism: An Anthology of Essays on the Thought and Influence of Emanuel Swedenborg* edited by Stephen McNeilly; *The Feeling of What Happens/Smile or Die* by David Lister; *Carl Bernhard Wadström: In Search of the New Jerusalem* by PL Johnson; *The Garment of Love: Charity is the Bond of Perfection* by Anders Hallengren; and *Slipknots* by Jane Lee.

Philosophy, Literature, Mysticism is an anthology of twenty essays edited by Stephen McNeilly with a foreword by Inge Jonsson, Professor Emeritus of Comparative Literature at Stockholm University. Of the contributions, three are by the late Czeslaw Milosz, winner of the Nobel Prize for Literature in 1980, and two are by the late Eugene Taylor, Founder/Director of the Cambridge (Massachusetts) Institute of Psychology and Comparative Religions. Eight of the essays are collected from earlier volumes of the Journal of the Swedenborg Society, but many are published here for the first time, including four by contributors whose work has not previously been published by the Society, Keri Davies, Anna Maddison, Saori Osuga and Devin Zuber. While Stephen McNeilly states in his preface that an anthology cannot hope to be comprehensive, this book is a major publishing achievement for the Society, and, in particular, for Stephen McNeilly and his publishing team. The book has a full critical apparatus and is attractively designed and bound in hard covers with an intriguing dust jacket and a slipcase. It aims to establish itself as the most comprehensive single contribution yet on Swedenborg's influence on the history of ideas and a key textbook for undergraduate and postgraduate research into eighteenth- and nineteenthcentury studies.

*The Grand Theme* consists of eight essays by Anders Hallengren the Swedish author and leading Swedenborgian scholar who was President of the Society from 2011 until 2013. The book brings together a selection of Hallengren's work written over many years which explores the continuing influence of Emanuel Swedenborg through reflections on art, literature and music. The title comes from the second essay in the book, 'The Grand Theme: A Journey in the Musical Universe'. Two of the essays were delivered as lectures in Swedenborg Hall. 'Jardin des Plantes: The Most Important Place on Earth' was the author's Presidential address following the 2012 Annual General Meeting and a version of 'The Oceanic Mind' was given as the annual Swedenborg Birthday Lecture in January 2013. There is a substantial bibliography to each essay at the end of the book.

*Swimming to Heaven* by Iain Sinclair is the second book in the Swedenborg Archives series and is the same size and in the same format as his *Blake's London: The Topographic Sublime* published in 2011. Like the earlier book, this one is a revised transcript of a talk, this time at

Barnard's Inn Hall, Holborn in June 2009. Passages in the talk which explore the relation between Blake and Swedenborg have been extended and elaborated and Swedenborg's 'mud baptism' of 1744 is given prominence. The book has endnotes and a brief preliminary note by the series editor, Stephen McNeilly.

Three new *Swedenborg Society Transactions* were published in January 2013. They are: *The Feeling of What Happens/Smile or Die* by David Lister, Transaction No. 8, *Carl Bernhard Wadström: In Search of the New Jerusalem* by PL Johnson, Transaction No.9, and *The Garment of Love: Charity is the Bond of Perfection* by Anders Hallengren, Transaction No. 10. All are transcripts of lectures given in the Hall in recent years. They are bound in uniform style and printed in a limited edition on quality paper. Each copy is numbered and signed by the author. In addition to this a small volume entitled *Slipknots* by the writer and academic Jane Lee was also published during the autumn. This was printed in a special limited edition of 27 to accompany her talk in Swedenborg Hall during the Bloomsbury Festival in October.

Kenneth Ryder completed a second draft of a new translation of *Divine Love and Wisdom*. The Rev. Alan Lewin continued as his consultant for this work. Typesetting continued on the Rev. John Elliott's dual language edition of *De Domino/The Teaching of the Lord* and this work was almost ready for the printer at the end of the year. John Elliott made further progress with his dual language version of *De Scriptura Sacra/The Teaching of the New Jerusalem concerning Sacred Scripture*. The Rev. Robert Gill is his consultant for this work.

Typesetting of volume 3 of the Rev. Norman Ryder's multi-volume work, *A Descritptive Bibliography of the Works of Emanuel Swedenborg (1688-1772)*, got well underway during the year. An eight-page supplement to volume 1 of the *Bibliography* was published during the year.

Further work was done on volumes 6 and 7 of the *Journal of the Swedenborg Society*, a volume of essays on Swedenborg's mathematics and science by David Dunér of Lund University, Sweden, and a biographical study of James John Garth Wilkinson, the eminent 19<sup>th</sup> –century British Swedenborgian thinker and a prominent member of the Society, by Malcolm Peet.

Another publication in course of preparation is an essay on Swedenborg and Jorge Luis Borges by William Rowlandson, Senior Lecturer in Hispanic Studies at the University of Kent, an expanded version of a talk he gave to the Society in July 2013.

Enquiries had been made during the year of Oxford Classics, Everymans Library and Penguin Classics with a view to one of these publishing the Ryder translation of *Heaven and Hell* in paperback.

# ADVISORY AND REVISION BOARD

The Board met on 6<sup>th</sup> March and 12<sup>th</sup> September to review the Society's ongoing literary projects and consider proposals for new ones. Books seen through the press this year included Anders Hallengren's *The Grand Theme and other essays* and *Philosophy*,

Literature, Mysticism: An Anthology of Essays on the Thought and Influence of Emanuel Swedenborg, edited by Stephen McNeilly. Progress on a new translation of Divine Love and Wisdom (see above) has reached the stage of a third and final draft. Work also continues on Norman Ryder's Descriptive Bibliography with the final portions of volume 3 being typeset for publication in late 2014. Also being typeset for publication in 2014 is a dual language edition of Doctrina Novae Hierosolymae de Domino. Dual language editions are also being prepared by John Elliott and Robert Gill of The Teaching of the New Jerusalem concerning Sacred Scripture, Faith and Life (three separate volumes).

# LIBRARY AND ARCHIVES

The online catalogue remains the library's primary concern and, on that front, Alex Murray, the assistant librarian, has continued to work three days a week on this huge project. A decision was taken to catalogue the archive holdings in greater detail so that files and items are not only recorded, but re-ordered and (where possible) re-housed in better preservation equipment. The two main sections of the archives and library worked on this year were: section K, covering correspondence (one of the sections most accessed by researchers); and section S4, covering pamphlets and printed sermons. Over 6,400 items have now been catalogued and listed online, including many files of correspondence which, whilst being recorded as single items, now contain details of each of the many letters of which they are comprised.

The growth of the online catalogue has seen an increase in the number of researchers visiting Swedenborg House and also the number of research enquiries coming in by email, post and over the telephone. The library has this year received generous donations from the Swedenborg Foundation and from the estate of Margaret Evans, as well as numerous items from the now defunct New Church House in Manchester, including first editions of Swedenborg owned by John Clowes and Clowes's writing desk.

The considerable investment of finance, time and effort into the library over the last few years has been pursued by the Society with no costs (only benefits) to the researchers who use it. In the future library users will be asked for a small show of support for the facilities they use. It is proposed that the library should become a members' library from 2015 so that researchers wishing to access our collections who are not already members of the Swedenborg Society will be asked to become members of the Society.

# DISTRIBUTION

**Sales.** The gross retail value of books sold was £19,024, compared with £25,426 in 2012. Countersales in the shop were £6,894 (£8,510 in 2012).

**Grants.** Grants of books totalling £1,647 were made to libraries and individuals around the world, excluding the special grant of books to South Africa mentioned below.

# GRANT OF BOOKS TO SOUTH AFRICA

A total of 1,785 books in 85 boxes with a retail value of £22,657 were shipped to South Africa for members of the New Church in Soweto. A grant of £2,000 was received from the Basil Lazer Trust in Australia which covered the shipping costs. The Society is most grateful for this. It is hoped that this may be the first of substantial grants of books, all of them recent translations of Swedenborg's writings, which the Society wishes to make available to readers of Swedenborg around the world who might otherwise find it difficult to buy these books themselves.

# SWEDENBORG PUBLISHERS INTERNATIONAL (SPI)

The Society is a member of this umbrella body which provides funding for translation and publishing projects around the world. No payments were made to SPI during the year. Individual contributions received for SPI projects and the Society's own annual contribution to SPI will be applied to SPI projects during 2014.

# PUBLICITY

Publicity about Swedenborg and the Society's activities was given in a number of ways throughout the year. Nora Foster continued to manage the website and edit a lively, regular online newsletter sent to a mailing list of over 1,200 individuals. James Wilson took over the editorship of the online newsletter after Nora Foster's departure. Good use was made of the Facebook page and Twitter account to make the Society better known and to advertise our own events. The Swedenborg House blog contains a rich store of fascinating material to attract the reader.

As usual, the Society was open to visitors as part of Open House London on the afternoon of 21<sup>st</sup> September when there were about 300 visitors. Patrick Johnson edited a further three issues of *Things Heard and Seen* which is posted to all members and some others and is available free of charge in the bookshop. In its issue of 8<sup>th</sup> November 2013 *The Times Literary Supplement* published a learned and fascinating history of the journeys of Swedenborg 's skull by Damian Walford Davies, Professor of English at Cardiff University. The issue of 22<sup>nd</sup> November published a short response to that article by Richard Lines. A review by Richard Lines of Kenneth Ryder's translation of *Heaven and Hell*, originally published in *Things Heard and Seen*, was published in the *Journal for the Study of Spirituality*, Vol. 3 No 1, May 2013 (web).

# LECTURES AND MEETINGS

On Saturday the 26<sup>th</sup> January the President, Dr Anders Hallengren, delivered the annual Swedenborg Birthday lecture on 'The Mystic with an Oceanic Mind', about the influence of Swedenborg in the Caribbean and Latin America. A revised, expanded and printed version of this lecture is one of the essays in Anders Hallengren's book *The Grand Theme and other essays* which is mentioned in the first section of this report. On the 27<sup>th</sup> June immediately following the formal business of the Annual General Meeting Anders Hallengren gave a brief introduction to his book and *The Grand Theme* was duly launched. On Thursday 4<sup>th</sup> July Gary Lachman and Dr Marsha Keith Schuchard debated 'Writing Swedenborg'. On Thursday 11<sup>th</sup> July Dr William Rowlandson of the University of Kent gave a lecture on Jorge Luis Borges and Swedenborg following the publication of his book *Borges, Swedenborg and Mysticism* (2013) Finally, David Lister spoke about 'Biblical Darwinism' on Thursday 25<sup>th</sup> July.

# CURATED EVENTS

Once again, the Society enjoyed an exciting and varied programme of events organized by Stephen McNeilly (curator) and Nora Foster (assistant curator).

The first event of the year was a series of four evening lectures by leading academics on architecture and philosophy in May and June organized by Architecture Exchange in collaboration with the Society. These were well attended and created some useful publicity for the Society for the Society in hosting them.

Following the Annual General Meeting on the 27<sup>th</sup> June there was a lively discussion of the flag competition led by Stephen McNeilly. The online ballot had not led to a clear winner, but this did not dampen the enthusiasm of the members present, The winners, Christina Mirentse and Michael Hampton, were finally announced on Thursday 17<sup>th</sup> October, and the new flag was unfurled.

On the 30<sup>th</sup> July there was a day of screenings of Fritz Lang's *Dr Mabuse* films in conjunction with the launch of *Swimming to Heaven* by Iain Sinclair. The screenings were part of the 70x70 series of film screenings in honour of Iain Sinclair's 70<sup>th</sup> birthday. Other screening venues included the Barbican, the Whitechapel Art Gallery and Tate Modern. The event drew a large audience and there were many book sales. Howard Turner gave valuable technical assistance with the film screenings.

On Thursday 5<sup>th</sup> September there was an evening devoted to photography. First, Alex Murray our assistant archivist spoke about links between Swedenborg and spiritualism in the 19<sup>th</sup> century and then Alison Gill spoke about the role of Kirlian photography in her art.

On Thursday 17<sup>th</sup> October, as part of the Society's contribution to the Bloomsbury Festival, an exhibition of spectacular drawings in black and white by the Society's artist in residence Peter Cartwright opened top the public. Peter had used his residency to make drawings which represented his reaction to Swedenborg House and its various uses. On the following evening Jane Lee gave a series of readings from her book *Slipknots*.

The fourth international Swedenborg Short Film Festival attracted 120 entries. The judges, Peter Fillingham former head of Sculpture at Central St Martins, writer and journalist Sukhder Sandhu, and Nora Foster selected a winner from the shortlist of films screened on 29<sup>th</sup> November. A large and appreciative audience attended this event and the award for best film was presented to Nick Jordan for his film entitled *Nature House Inc.*.

Eoin McMahon, assisted by Gusztav Varga, served wine, beer and soft drinks at all events.

Finally, members and guests were gathered in the bookshop on the 17th December to drink mulled wine and enjoy a reading of Amelia Edwards' Victorian ghost story *The Phantom Coach*. The evening was organized by Vicky Rood.

# MEMBERSHIP

Twenty-three new members were enrolled during the year. The deaths of 16 members were reported to the Society. Two members resigned their membership. The total membership is 879 (874 in 2012).

# FINANCE

Total incoming resources for the year amounted to £738,112 (£292,726 in 2012). Voluntary income was £463,450, of which £446,000 came from legacies. It should be noted that the Society had an operating surplus of £1,000 before taking account of legacies. Investment income was £208,970 (£206,331 in 2012). Income from the hire of rooms was £45,566 (£44,501 in 2012) and book sales were £20,126 (£21,945 in 2012). Total resources expended were £290,396 (£320,190 in 2012), giving a surplus for the year of £447,716. The total value of the investment portfolio at 31<sup>st</sup> December 2013 was £4,628,191 (£3,720,588 at the end of 2012).

The Society's investment objective is to produce a balance between immediate income to support current projects and longer-term capital appreciation. This is achieved through a diversified portfolio with a medium-risk profile, comprising a mixture of equities and fixed interest stocks with a ratio of 75% equities and 25% fixed interest. It is considered that this objective was achieved during the year.

# **RESERVES POLICY**

Of the Society's declared objectives, we regard the work of translation, revision and publication as our highest priority. Here finance is not the only restriction; human resources, in the form of capable, specialised translators, are vital to our work. Much of this work is of a long-term nature, and designated reserves are justifiable to ensure continuity in our long-term operations.

Part of our income arises from property. We own a freehold building which provides facilities for our activities (as well as rooms we can hire out to others), together with office space which is commercially let. Both the income and associated expenses vary widely, and justify a specific reserve to cover fluctuations.

Another part of our income, albeit unpredictable, comes from gifts and legacies. In the absence of specific restrictions, it has been our past practice to add these to our general fund to provide sufficient investment income. We would seek to continue this practice, but recognise our duty to apply the resulting increased income to further our charitable objects. Our policy, therefore, is to keep our operating surplus/deficit within+/-5% of annual income averaged over three years. For the purpose of calculation, we would exclude any gifts or legacies. These will be added to the Society's reserves to generate additional income for the future. This policy is subject to development, and is reviewed at intervals of not more than three years.

# PREMISES

Eoin McMahon continued to take excellent care of the premises and to engage contractors and project-manage their work. No major property projects were undertaken during the year, although routine maintenance of the building is an ongoing task requiring constant vigilance. The new telephone system has been operational from the beginning of the year and has proved successful. The Hall and the other rooms were used by a wide variety of organisations throughout the year and Eoin McMahon, with the assistance of Gusztav Varga, has the task of supervising hirers while they are in the building.

# COUNCIL AND OFFICERS

Mr John Cunningham, a long-standing member of the Council and Chairman of the Council from 1993 to 2006, was elected President of the Society for the year 2013/14 at the Annual General Meeting held on 27<sup>th</sup> June. At the same meeting Dr Anders Hallengren and Mr David Lorimer were elected as Vice-Presidents of the Society for the year 2013/14, and Mr Alec Morley was elected as Hon. Treasurer for the same period. Miss Margaret Fleming and the Rev. Alan Lewin retired by rotation under Article 32 of the Society's Articles of Association. Neither offered themselves for re-election. Mr PL Johnson also retired by rotation under Article 32 and he offered himself for re-election and was duly elected as an ordinary member of the Council. The Rev. John Elliott retired as a Vice-President, having served as President of the Society from 2006 to 2009 and thereafter as a Vice-President. He did not seek election as an ordinary member of the Council. No nominations for election as ordinary members of the Council had been received, but the Chairman of the Council pointed out that the Council had the power to co-opt members to the Council during the course of the year.

All paid-up members of the Society are eligible for election to the Council, which is the Society's decision-making body, in accordance with the procedures set out in the Articles of Association. The Council has the power to fill casual vacancies by co-option. New members of the Council are given copies of the Memorandum and Articles of Association and are advised by the Secretary of their duties as company directors and charity trustees. Council decisions are taken by majority vote.

# ORGANISATION

The senior staff, Richard Lines, Company Secretary, Stephen McNeilly, Publications Manager, and Eoin McMahon, Property Manager, all remained in post throughout the year, as did James Wilson, Assistant Editor and Librarian and Alex Murray, Assistant Librarian, whose contract was extended for a further year until 30<sup>th</sup> April 2014. Nora Foster, Assistant Curator and Sales and Publicity Representative, left at the end of October after nearly five years with the Society to develop her career with a post on an art magazine. She has not been replaced for the present, but James Wilson and Alex Murray have extended their working weeks to five days and four days respectively in order that the shop may be covered. Creighton Mackay, who had kept the Society's books and prepared the Annual Accounts since 2006, decided not to continue working for the Society in June. Victor Coles FCA was appointed to replace him as a contractor and he has proved a worthy successor. Gusztav Varga has continued to assist Eoin McMahon as evening and Saturday doorman and in other ways. He has also proved a good book salesman on a number of occasions. Patricia McMahon has continued to assist Eoin with the cleaning of the building. Many thanks are due to Nora Foster and to Creighton Mackay for their work for the Society over a number of years.

As well as paid staff and contractors, the Society has also had the help of a number of volunteers. Diane Lewin assisted Nora Foster in the shop on two afternoons a week until June when she and her husband moved to Manchester. The Society is sorry to lose her valuable services and cheerful presence in the shop. John Cunningham has continued to attend regularly at Swedenborg House, giving valuable service in the bookshop to relieve staff members, as well as continuing to help Eoin McMahon with numerous small maintenance jobs around the building. David Lister has also attended once a week throughout the year. Towards the end of the year Michael Hiller began to give useful help in the shop on Wednesday lunchtimes. Also in the late autumn Vicky Rood, an English graduate, started as an unpaid intern in the publishing office working one day a week.

# **COMPANY MATTERS**

This report represents a Directors' Report as required by section 417 of the Companies Act 2006. The Society has taken advantage of the exemption available to small companies under Part 15 of the Companies Act 2006 in the preparation of this report.

# PUBLIC BENEFIT

The Society has complied with the duty imposed by section 17 of the Charities Act 2011 to have regard to public benefit guidance published by the Charity Commission. The Council considers that, having regard to its translating and publishing programme, its bookshop, its programme of lectures and events (which are open to the public) and to the publicity given through the website, leaflets and press releases, the Society is acting for the public benefit in pursuance of its aims and objects as set out at the front of the report.

# COUNCIL

# CONCLUSION

There are two items in this report to which we wish to draw your special attention. The first is the publication of a volume of essays edited by Stephen McNeilly, our Publications Manager, entitled *Philosophy, Literature, Mysticism: An Anthology of Essays on the Thought and Influence of Emanuel Swedenborg.* This is a fresh step towards encouraging a wider appreciation of Swedenborg's work. We think that the Society has much to offer in widening and deepening interest in him, both as a scholar and as a mystic. The second noteworthy item is the continuing reorganisation and computerisation of books and archive material. As you can read in the section on Library and Archives, over 6,400 items have now been catalogued. This has led to an increasing number of people visiting our library and archive material, both in our building and on the web. We would like to express our glad appreciation of this achievement to James Wilson and Alex Murray for all the work they have put into it. We would also like to thank Eoin McMahon, our Property Manager, for the beautiful state of our premises which has been commented on and admired by several visitors.

Finally, at the end of the year the Council approved a five-year 'enhancement programme' to invest the generous legacies of over £400,000 received in 2013 with the intention of increasing public awareness of Swedenborg, his writings and their influence in a number of ways. These will include innovations in marketing and distribution in order to increase book sales and knowledge of Swedenborg and his influence generally; the funding of residencies and scholarly research; and collaboration with other bodies. In this way it is hoped that the Society's charitable aims can continue to be fulfilled and expanded in the coming years.

#### 1. ACCOUNTING POLICIES Accounting Convention

The accounts are prepared on a going concern basis, under the historical cost convention as modified by the revaluation of certain fixed assets and to include a nominal value of stocks.

#### **Compliance with Accounting Standards**

The financial statements have been prepared in accordance with the Statement of Recommended Practice (Revised 2005) "Accounting and Reporting by Charities" ("SORP 2005") and applicable accounting standards and the Companies Act 2006, except as noted below.

As the company is a small company as defined by the Companies Act 2006 it is exempt from preparing a cash flow statement and has taken advantage of this exemption.

#### **Fixed Assets**

The freehold land and property is stated at valuation. Matthews and Son, Chartered Surveyors prepared the current valuation, on 31 December 2001. The directors consider the appropriateness of the valuation at the end of each financial year and consider whether there has been any impairment in the value of the property. No depreciation is charged in relation to the property as the directors consider the annual charge would be immaterial taking into account the residual value of the property. See note 8 for further information. Costs of improvements to the property are charged to expenditure within the statement of financial activities annually.

Fixtures, fittings and office equipment are depreciated on the following basis:

Fixtures and fittings 4 years/15 years - straight line Office equipment 50% - straight line

#### **Heritage Assets**

The Society holds an extensive library and archive relating to the life and works of Emmanuel Swedenborg, held primarily for the purposes of transferring knowledge and promoting culture which are disclosed on the Balance Sheet as heritage assets. This collection is considered to be a heritage asset and is stated in the balance sheet at an attributed value based on the insured value and, as allowed by FRS 30, is not depreciated as it is considered to have an indefinite life. Following the implementation of FRS 30 material additions to the library will be capitalised.

#### Investments

Investments are stated at market value. Realised and unrealised gains on revaluation are disclosed in the Statement of Financial Activities. Realised gains are calculated as the difference between sale proceeds and market value, or cost if acquired during the year.

#### Stocks

Stocks of books, printed sheets and papers are included in the accounts at a nominal value of  $\pounds 100$ , based on significant uncertainties with regards to the realisable value of the books held. Disposal proceeds and acquisition costs are taken to the Statement of Financial Activities in the year in which they are received/paid.

#### 1. ACCOUNTING POLICIES (Continued)

#### Legacies and Gifts

Legacies and gifts are credited to the Statement of Financial Activities when there is reasonable certainty of receipt and the amount can be ascertained.

#### Sales of Books

Sales of books are stated net of trade discounts to customers.

#### **Investment Income**

Investment income is accounted for in the Statement of Financial Activities on a receivable basis.

#### Costs of Generating funds

Costs of generating funds include all publicity expenses incurred in raising the profile of the Society.

#### Shop and Stock Rooms, Library and Hall Expenses

Shop and stock rooms, library and hall expenses comprise direct expenses and a proportion of the total property expenses, based on estimated floor space, as follows:

The freehold land and property is stated at a valuation which was prepared in 2001. The directors consider the appropriateness of the valuation at the end of each financial year and consider the value included in these financial statements to be materially correct. However under accounting standard FRS 15, Tangible Fixed Assets, a formal valuation should be undertaken by a property professional on a regular basis to confirm that the valuation is still appropriate. The trustees do not consider that it is a good use of the society's limited resources to pay for a valuation and therefore a valuation has not been obtained. This policy does not accord with the requirements of FRS 15.

The library and archives are heritage assets. They are included in the financial statements at a valuation based on insurance value. The valuation was undertaken internally prior to 2005 and is reviewed on a regular basis by the Society. The library was established in1824 and provides an important resource for those researching Swedenborg. It has four main sections: The Swedenborg Collection; the Archives; Collateral titles; and Periodicals. The library is a research library and is open to members of the Society and non-members.
